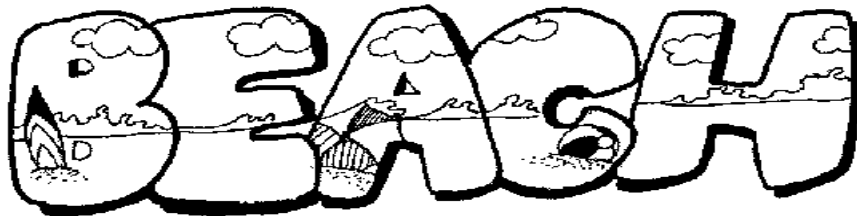

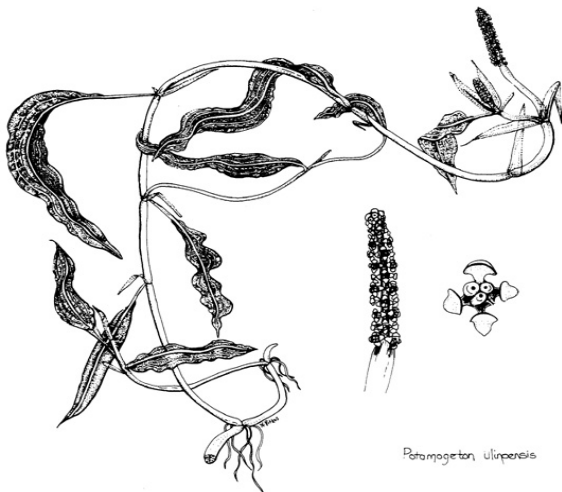

Minutes from the Mid-Winter Board Meeting February 11, 2002 (Birmingham, Alabama)

The meeting was called to order at 10:05 AM by President David Franks. Attendees included Ken Weathers, Renee Beam, Tom Broadwell, Chris Greene, Wes Anderson, Joe Jernigan, and Don Morgan. The board thanked Alabama Power for their hospitality and use of the meeting room. The minutes from the October 24, 2001 board meeting were presented and David Franks made a clarification for out-of-pocket expenses. The minutes were revised to reflect this clarification. A motion was made to accept the minutes, seconded, and the minutes were accepted by voice vote.

Financial Report

All invoices for the Plymouth Bluff meeting have been processed. Renee Beam presented the financial statement. Operating Fund: \$17,894.02 as of 1/31/2002; MSAPMS scholarship 13 Month CD: \$14,926.40; Alabama Power Scholarship 13 month CD: \$11,396.23. A motion was made to approve the financial report, seconded, and the financial report was accepted by voice vote. The archiving of historical records is proceeding. The idea of utilizing a professional money manager was discussed; however, the board decided not to pursue this idea.

Annual Meeting

Tom Broadwell presented a potential location, meeting room costs, and options for the banquet meal for the fall meeting. A motion was made to accept Gulf Shores as the site for the fall meeting, the motion was seconded, and by voice vote the motion carried. There was discussion on the registration fee. A motion was made to increase the registration fee to \$40.00 for pre-registration (15 days in advance of the meeting) and \$50.00 for late registration and at the door. The motion was seconded and accepted by unanimous voice vote. The dates for the fall meeting will be October 16-18, 2002.

Applicator Re-certification Points

Scott Lankford was invited to make a presentation on the status of applicator re-

certification points. Scott thoroughly discussed the process and stated that paperwork for the fall meeting had been processed. CYLINDROSPERMOPSIS: An Invasive Toxic Algae

Cylindrospermopsis is considered a subtropical alga; originally identified from India in 1913 (Desikachary 1959). It thrives in high-nutrient, high-temperature, stable waters. It also does well in shallow, well-mixed, highly eutrophic reservoirs. In the last 10-15 years *Cylindrospermopsis* has been spreading throughout North America, particularly in the West and North. Similar patterns have been observed in Europe as well. Difficulties in identification and confusion with other miscellaneous blue-green algae filaments indicate that there are likely many more occurrences.

It's believed that *Cylindrospermopsis* first started appearing in Florida sometime in the last 30 years or so (Chapman and Schelske 1997). Since then, it has dominated several central Florida lakes to the extent that it grows almost as a single species bloom within the lake, often reaching amazing densities of hundreds of

thousands of cells per ml. These blooms can last for months on end and affect both recreational lakes and drinking water supplies. Bloom patterns in more Northern and Southwestern states are different, with very late summer blooms that are much more punctuated, often not appearing until August, September, or October, and lasting only a few weeks.

Cylindrospermopsis raciborski or "Cylindro" as some folks call it, is a toxic, filamentous blue-green alga. Unlike more common blue-greens, such as *Anabaena flos-aqua*, *A. circinalis* or *Microcystis aeruginosa*, *Cylindrospermopsis* is small and indistinct at first glance.

Cylindrospermopsis has several characteristics that also distinguish it from the other toxic blue-green algae. Unlike *Microcystis*, for instance, that produces generally one toxin type (microcystin, over 60 analogues), *Cylindrospermopsis* produces at least 3 distinct toxins. Cylindrospermopsin, anatoxin-a, and saxitoxin all can be highly toxic and in high enough doses, lethal to animals (cattle, alligators, and dogs seem to be the hardest hit) and humans. Although there have not been any documented human deaths from *Cylindrospermopsis*, there have been many serious hospitalizations. In 1979, almost 150 people, most of them children, had to be hospitalized for treatment of liver damage, after drinking water from a reservoir contaminated with *Cylindrospermopsis* on Palm Island in Australia (Chorus and Bartram 1999).

Drinking water treatment strategies are not always successful at removing toxins and treating with copper sulfate lyses cells and liberates toxin directly into the water, making treatment even more ineffective. The 1979 Australian event followed a reservoir-wide copper sulfate treatment.

Finally, most of the planktonic toxic blue-green algae form scums on the surface of the water. Not so for *Cylindrospermopsis*, which often stays well-distributed throughout the water column and has the highest concentrations below the surface. In fact, other than a deep green-brown color, it's often difficult to determine that a serious blue-green bloom is occurring at all.

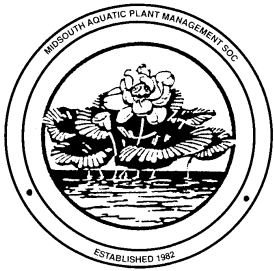
